1. Detailed description of goods and/or services

EJ Auto Electrical CC is a business in the Online Shop Service that supplies accessories to clients, we list items for various suppliers all over South Africa, the address below is the collection/dispatch point for these services and items.

2. Delivery policy

Subject to availability and receipt of payment, requests will be processed within 3-7 working days and delivery/self-collection confirmation will be sent via e-mail confirmation once the order is to be processed, along with the relevant waybill details if applicable.

EJ Auto Electrical does not hold all stock on hand at our dispatch premises, we do advertise for our suppliers and have supplier agreements in place and some goods may be dispatched directly from their premises, or ordered/manufactured once your order is received and then delivered to us to dispatch. You will be advised should this be the case.

EJ Auto Electrical makes use of various suppliers / vendors and Courier Companies for Delivery, we are unfortunately unable to control any delays due to strikes/delayed flights/ factory closures due to public holidays or over the festive season/weekends or any breakdowns etc. Where extended delays may occur, you will be advised accordingly should this effect your order in any way.

3. Export restriction

The offering on this website is available to South African clients only.

4. Return and Refunds policy

The provision of goods and services by EJ Auto Electrical is subject to availability. In cases of unavailability, EJ Auto Electrical will credit the client in full within 30 days via a credit amount on the online store or via refund to a valid bank account in the name of the client (proof may be required). Cancellation of orders by the client will attract a 20% administration/handling fee.

○ Returns

- Returns will be accepted within 14 days if goods are unused and in original packaging, undamaged, same process applies as the refund policy.

- Out of box failure will be accepted to be returned and exchanged at no additional fee to you as the customer.
- **Damaged or Unwanted Goods**
 - Damaged Goods: Please notify us within 24 hours of receipt if your goods arrive damaged, are missing parts, or are inoperable.
 - Return of Correctly Supplied Goods: All goods must be returned within 7 working days of receipt. Please contact us before returning to confirm the return process.
- **Important Notes on Returns:**
 - You are responsible for the cost of return shipping which is factored into a handling fee.
 - Returns will not be accepted after 14 days from receipt based on courier tracking.
 - Electrical items are non-returnable.
 - A 20% handling fee applies to returned or canceled orders.
 - Used, fitted, or altered items cannot be returned.
 - Returned goods must be in a sellable condition and in their original packaging.
 - If returning goods via courier, please ensure they are packaged carefully to prevent damage during transit. Please contact our office by email beforehand and ensure you have a copy of the original invoice and include the original invoice in with the return item.
- Please allow up to 10 working days for a refund to your card account if you have paid via Payfast as we need to request a refund from Payfast itself.
- For assistance with returns or to initiate a return, please contact our customer service team using our email ejautoelectrical@gmail.com. We are committed to ensuring a smooth and satisfactory experience for all our clients.

5. Product Warranties

All goods come with a 6-month manufacturer warranty, except for:
